ARIA CLASSIFICATION GUIDE FOR ADULT REGIMENS



The diagnosis entered by the clinician using the ICD-10 code directs the prescriber to the appropriate disease folder in the prescribing window when starting treatment. Therefore the following disease sites should be assigned when building and validating regimens, only those listed below should be used as these have been tested and it is recognised that some disease sites do not function as expected. In some circumstances it may be necessary to assign a Cancer Category when a disease site is broken down by cell type e.g. leukaemia. Due to the large number of anatomical sites for Upper GI tumours, it has been agreed that all protocols pre-fixed UGI should be assigned to the disease site Digestive (Misc.), however the clinician will not automatically be directed to this folder after entering the diagnosis. In some circumstances it may be necessary to assign more than one disease site e.g. Colon and Rectum for a regimen used in both of these disease sites.
